

POA FOR PAY-IN OF SECURITIES FOR THE PURPOSE OF SETTLEMENT

TO ALL TO WHOM THESE PRESENTS SHALL COME, I/we _____, residing at/having place of business/registered office at _____ India, Indian inhabitant send greetings.

Whereas I/we hold beneficial owner account number 12082400 _____ with Central Depository Services (India) Limited, through Ganganagar Commodity Limited bearing DP-ID 12082400 (DP- SEBI registration No. IN-DP-679-2022).

And Whereas I/we am/ are desirous to buy and sell securities through Ganganagar Commodity Limited who is a member of National Stock Exchange of India Ltd, Bombay Stock Exchange Ltd bearing SEBI Registration No. (NSE- INZ000016737) and (BSE- INZ000016737). And Whereas I/ we am/ are desirous of appointing Ganganagar Commodity Limited as my/our constituted attorney to operate my / our beneficial owner account on my/our behalf for a limited purpose in the manner hereinafter appearing and subject to conditions as provided herein.

Now know you all and these presents witness that I/we do hereby nominate, constitute and appoint Ganganagar Commodity Limited hereinafter referred to as "the stockbroker") as my true and lawful attorney and authorize it to perform the following function on my behalf:

- i. To transfer securities held in my/our aforementioned beneficial owner account(s) to the stock broker from time to time to the demat account nos. (CM Pool A/c - 1208240000002082 - 1100001100020001), (CM Principal A/C- 1208240000002025 - 1100001000023819), 1208240000111495 (Margin Pledge Account) of the stock broker maintained for the purpose of settlement of trades and margin obligations arising out of trades executed by me/us on any recognized stock exchange through the stock broker. However, the said power will be restricted to only transfer of securities to the Clearing Member ID allotted to the stock broker by any existing or future exchange that the stock broker has joined/will join as a member or to any demat accounts linked to the said Clearing Member ID provided that I/we have executed a Client Member Agreement with the stock broker for such exchanges.
- ii. To pledge/re-pledge the securities in favour of the stock broker for the limited purpose of meeting my/our margin requirements in connection with the trades executed by me/us on any recognized stock exchange through the stock broker.
- iii. To return to me/us, the securities that may have been received by the stock broker erroneously or those securities that the stock broker was not entitled from me/us;
- iv. To send consolidated summary of my/our scrip-wise buy and sell positions taken with average rates to me/us by way of SMS/email on a daily basis, notwithstanding any other document to be disseminated as specified by SEBI from time to time.
- v. To apply for various products like Mutual Funds, Public Issues (shares as well as debentures), rights, offer of shares tendering shares in open offers etc pursuant to oral/written/electronic instructions given by me/us to the stockbroker.

I/We ratify the instructions given by the aforesaid stock broker to the depository participant named hereinabove in the manner specified herein.

I/We further agree and confirm that the powers and authorities conferred by this Power of Attorney shall continue until it is revoked (without notice), in writing by me and that the said revocation shall be effective from the date on which the revocation notice is received by the stock broker in his office at
